Subject- Relaxation to the institution/s located in UTs of J&K and Laddakh-regarding.


Sir,

I am directed to refer to your letter No. NCTE-Regl011/575/2022-Reg. Sec (JK)-NRC/222300 dated 27.06.2023 on the subject cited above and to say that the Ministry of Education vide its letter No. 21-2/2021-IS.1 dated 15.09.2023 (Copy enclosed), has conveyed the approval of the competent authority under Section 29 of the NCTE Act, 1993 to the proposal contained in Para 5 of the above mentioned letter of NCTE subject to the following conditions:-

- i. All the institutions will have to submit compliance to the deficiencies pointed out by NRC on or before 30th October 2023, so as to enable NRC to take final decision on the application of the institution / University.
- ii. No admission can be made for the academic session 2024- 2025 without formal recognition from NRC-NCTE
- iii. The relaxation will be applicable to all the 140 institutions, as per list at Annexure-23 of the abovementioned letter of the NCTE for the course(s) as mentioned against each institution.

2. In view of the above, the NRC is requested to take further action strictly in accordance with the NCTE Act, 1993 and NCTE Regulations 2014 as amended from time to time.
